

A LAW TO AUTHORISE THE ISSUE FROM THE CONSOLIDATED REVENUE FUND OF ONDO STATE OF NIGERIA, A SUM OF ONE HUNDRED AND FORTY-THREE BILLION, FIVE HUNDRED MILLION NAIRA (N143,500.000,000.00) ONLY OUT OF WHICH THE SUM OF FIFTY-EIGHT BILLION, ONE HUNDRED AND NINETY MILLION NAIRA (58,190,000.000.00) ONLY IS FOR RECURRENT EXPENDITURE WHILE THE BALANCE OF EIGHTY-FIVE BILLION, THREE HUNDRED AND TEN MILLION NAIRA (N85,310,000,000.00) ONLY IS FOR CAPITAL EXPENDITURE FOR THE SERVICES OF ONDO STATE OF NIGERIA FOR THE YEAR ENDING THIRTY-FIRST DAY OF DECEMBER, TWO THOUSAND AND ELEVEN

Commencement

(1st January, 2011)

BE IT ENACTED by the Ondo State House of Assembly in this Legislative Session convened as follows:-

*Appropriation of
N58,190,000,000.00
Recurrent Expenditure*

1. The sum of Fifty-Eight billion, One Hundred and Ninety million, Naira only shall be appropriated from the Consolidated Revenue Fund during the year ending on the Thirty-First Day of December, Two Thousand and Eleven for the services as set out in the First Schedule to this Law.

*Appropriation of
N85,310,000,000.00
Capital Expenditure*

2. The sum of Eighty-Five Billion, Three Hundred and Ten Million Naira only shall be appropriated from the Consolidated Revenue Fund during the year ending on the Thirty-First Day of December, Two Thousand and Eleven for the projects as set out in the Second Schedule to this Law.

*Citation and
Commencement*

3. This Law may be cited as the year Two Thousand and Eleven Appropriation Law and shall come into force on the first day of January, Two Thousand and Eleven.
